Description of Session Formats Birds of a Feather (BoF) - An informal discussion session designed to connect the participants of shared topic of interests without a pre-planned agenda. Specific Issues of Discussion

In this session, Koo will showcase its journey as a recent entrant in the social media and its efforts to increase trust, safety and inclusion on the platform and attain what it believes to be the ideal standard for conduct for social media platforms. Primarily, the discussion will be around the content moderation efforts at Koo.



From being a largely Indian platform, Koo has recently made big strides to becoming a global platform and being loved and embraced by many language speaking communities across the world. Categories of content which are legally permissible differ from country to country. For example, some counties prohibit all forms of online nudity, some countries permit it to an extent with limitations, while some others have no restrictions. As an internet intermediary, our challenge is to accommodate the laws of each country we operate in and allow people to freely express themselves accordingly.

The Internet has become an integral part of people's lives, and social media is the most public part of an individual's private life. Social media has become an important tool by which people communicate, advocate and take in information. Despite the advantages, misuse and abuses on social media act as a hindrance to expressing oneself freely and safely.
