Specific Issues of Discussion

India is all set to preside over the G20 summit for 2023. Home to 560 million internet subscribers, second only to China, India has been balancing between promoting welfare policies for the second largest population and the aspirations to become a 5 trillion-dollar economy by 2024, thus presenting a unique set of challenges for a developing nation. This is an opportunity for Indians, and certainly pumps the aspiration of the youth. Indian youth constitute the largest demographic of Internet users and as per UNFPA projections, India will continue to have one of the youngest populations in the world till 2030.



Being the next generation of internet users, youth need to be a part of the governance of the internet and hold center stage during decision-making processes. Therefore, with youth as a key stakeholder, this session intends to shed light on how the digital ecosystem can be made more youth-inclusive and participatory in the decision-making processes amidst digital transformations. With this backdrop, we shall attempt to understand the opportunities and challenges for youth from the lenses of interdisciplinary speakers coming from technical, socio-political, and business backgrounds.
